I then searched the book club on Facebook. It is called "Project Lit Community" and another called "Project Lit Community Chapter Leaders." To view that group, one must be a chapter leader. It is billed as a grassroots literacy movement. I then remembered I had read on social media one of our media center specialist talk about the book list. Next, I checked to see if our public library had a copy to checkout. I was able to checkout the book on 10/26. I began reading the book in parts. After reading the table of contents, two chapters caught my eye: Chapter 11 "Boys Will Be Boys" and Chapter 15 "Losing My Virginity Twice." sex and the older teen teaches him how to masturbate. He is told to keep it secret and this is what boys do. Chapter 15 is when the author loses his virginity twice. For 15 pages he describes his first adult encounter in very graphic details and steps of how he first sodomized another male and then later he was sodomized by the other male. A part of this chapter includes masturbation, oral sex, and sodomy twice signifying him losing his virginity twice, when he was sodomized, it was sadistic in nature as he did not speak up when he was in pain and tells the reader he was in severe pain still days later.

findings to the Superintendent Cathy Mittelstadt and School Board Attorney Kristy Gavin. I made it clear I wanted whoever was responsible for putting those books in our Media Centers held accountable for this crime committed on our children; obviously the books pulled; all young adult books checked, and the other school board members to be made aware. After Cathy Mittelstadt and Kristy Gavin knowing this information for 6 full days as well as school board policy 210, A, Communications which states the superintendents responsibilities to communicate in a timely fashion to ALL board members as well as distribute all school board member requests to the other board members, I determined they are not being responsible and to get the sheriff's office to investigate this crime.
